

Dance Your Way To \$10K Official Contest Rules

These contest rules are specific to the above contest conducted by Audacy Detroit, LLC d/b/a WOMC, WYCD, WWJ, WXYT, and WZLH (individually and collectively, as applicable, the “**Station(s)**”). Except to the extent specifically set forth below with respect to this specific contest, the WXYT-FM general contest rules apply to this contest as well. A copy of these specific contest rules and the WXYT-FM general contest rules are available on the Stations’ websites at www.womc.com/rules, www.wycd.com/rules, www.wwjnewsradio.com/rules, www.971theticket.com/rules, and www.alt987detroit.com/rules. **To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this contest.**

THIS CONTEST IS BEING CONDUCTED BY MULTIPLE RADIO STATIONS. LISTENERS OF EACH OF THE FIVE (5) PARTICIPATING STATIONS, AND VISITORS TO EACH OF THE PARTICIPATING STATION WEBSITES, ARE ELIGIBLE TO ENTER AND WIN THIS CONTEST AS SET FORTH BELOW.

How to Enter

1. No purchase or payment of any kind is necessary to enter or win the Dance Your Way To \$10K (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. You must be eighteen (18) years of age or older and a legal resident of the state of Michigan as of the date of entry in this Contest in order to be eligible to enter and win. There are two (2) ways to enter this Contest:
 - a. *Online Video method of entry.* Starting on Monday, March 2, 2026 at approximately 12:00pm (ET) through approximately 12:00pm (ET) on Monday, March 30, 2026 (the “**Online Video Entry Period**”), go to www.womc.com/contests, www.wycd.com/contests, www.wwjnewsradio.com/contests, www.971theticket.com/contests, or www.alt987detroit.com/contests, click on the “Dance Your Way To \$10K” link and complete and submit the on-line entry form with the following (each, an “**Online Entrant**” or “**Entrant**”):
 - i. your contact information (name, address, daytime telephone number, email address); and
 - ii. upload a video of you, and only you, dancing. Video should not exceed thirty (30) seconds (longer videos will not be disqualified but Station judges will only view the first thirty (30) seconds of each entry and only the first thirty (30) seconds will be posted online, if applicable). The uploaded video must not exceed 200 MB in size and must be in one of the following video formats: .mp4, .mov, or .avi.
 - iii. **Only the individual who submits the entry can be depicted in the video.** No other person’s image, voice or talent can be captured in the video. **Any video with any other person(s) or more than one (1) person depicted in it will be ineligible and will be disqualified. ANY VIDEO THAT CONTAINS ANY MUSIC WHATSOEVER WILL BE IMMEDIATELY DISQUALIFIED.** Entrants may not even sing or speak the lyrics to any copyrighted song or any other copyrighted material in their video (no portion of copyrighted poems, etc.) unless the associated copyrights are owned by the Entrant and no one else (Station may require proof).

- iv. All Entrants who submit an entry agree to the following and Stations will require, as a condition of entry, that Entrants affirmatively check a box or an “I agree” button expressly confirming the following:
- Entrant represents and warrants that they are over 18 years of age and a legal resident of the state of Michigan.
 - Entrant represents and warrants that they own the rights to, or have obtained permission to use, the video submitted with the entry.
 - Entrant represents and warrants that there is only one (1) person visible in the attached video and that person is the Entrant.
 - Entrant agrees and acknowledges that Stations and Contest sponsors and their respective affiliates, parents, employees, agents and all other related sponsors may use for advertising and/or promotional purposes, Entrant’s name, image, video submission, other entry materials and/or biographical information on radio, TV broadcasts, newspaper advertisements, on websites and/or any other medium in connection with participation in this Contest or otherwise without the payment of any additional compensation.
 - Entrant understands and agrees that Stations shall be the sole and exclusive owner of the video submitted, whether or not the video is selected as a winner, and Entrant agrees to sign any documents requested by Stations to evidence such transfer of ownership.
 - By submitting a video in this Contest, Entrant agrees to indemnify Stations should any representations and warranties made by Entrant herein or in the applicable Contest rules prove to be false or inaccurate.
 - Entrant acknowledges and agrees that the Contest rules are available to them at www.womc.com/rules, www.wycd.com/rules, www.wwjnewsradio.com/rules, www.971theticket.com/rules, and www.alt987detroit.com/rules, has had an opportunity to review them before entering this Contest and agrees to be legally bound by those Contest rules.
- v. **By entering this Contest the Entrant consents to use of the video (in whole or in part) by Stations in any manner they see fit with no compensation to the Entrant. By submitting a video, each Entrant represents and warrants that they own the rights to, or have obtained permission to use, the video submitted with each entry. Further, each Entrant authorizes the Stations to post the video on the Stations’ websites or their Facebook pages or other social media sites.**
- vi. Video entries must not contain any indecency, profanity or obscenity as determined by Station in its sole discretion. Video entries must not contain or depict any registered trade/servicemark or other copyrighted material other than those owned or licensed by the Entrants or the Station or a Contest Sponsor. **BY ENTERING THIS CONTEST AND SUBMITTING A VIDEO, THE ENTRANT IS REPRESENTING TO STATION THAT THE USE AND DISTRIBUTION OF SUCH VIDEO WILL NOT VIOLATE OR INFRINGE UPON THE RIGHTS OF ANY THIRD PARTY, INCLUDING, WITHOUT LIMITATION, COPYRIGHTS OF OTHERS.** By submitting a video, Entrants agree to indemnify Station should any representations and warranties in these Contest rules prove to be false or inaccurate.
- vii. **By entering this Contest, Entrants understand and agree that Stations may elect to use any entry submitted for entertainment purposes and may choose**

to comment on, mock, poke fun at, and/or mimic any entry submitted. Entrants waive any right to make any claim against Station or any Contest sponsors with respect to any comments - disparaging or otherwise - made regarding such Entrant's entry.

At approximately 10:00am (ET) on Wednesday, April 1, 2026, up to ten (10) entries will be selected by Station staff and/or management from among all entries received during the Online Video Entry Period, based on evaluation of the submitted videos (in their subjective opinion) and/or any other lawful criteria Station judges deem desirable. Each selected Online Video Entrant will be notified, via the email or the phone number Online Video Entrant provided at the time of their entry, and will have twenty-four (24) hours from the time of notification to respond to the Station. Upon response to Station within the required deadline, and subject to verification of Online Video Entrant's eligibility and compliance with these Contest rules, each selected Online Video Entrant will be designated as a "**Qualifier**" in this Contest, receive one (1) qualifying prize (*as described in Section 12 below*), and be invited to participate in the Grand Prize Event (*as described in Section 6 below*). In the event an Online Video Entrant does not respond before the required deadline, or is determined to be ineligible, such Online Video Entrant will be disqualified and the Station may, but is not required to, select an alternate entry at its sole discretion.

- b. *On-Site method of entry.* Between approximately 9:00am (ET) and 10:59am (ET) on Saturday, April 18, 2026 (the, "**On-Site Entry Period**"), at Planet Fitness, located at 288 John R Rd, Troy, MI 48083, find the Station table, complete an official entry form (*while supplies last, no mechanical reproductions will be accepted*), and deposit the completed entry into the official entry box and be present at the time of the On-Site Entry drawing (each, a "**On-Site Entrant**" or "**Entrant**"). At 11:00am (ET) on Saturday, April 18, 2026, the Station will randomly select up to one (1) entry from among all entries received during the On-Site Entry Period and announce the On-Site Entrant's name three (3) times. The On-Site Entrant whose name was announced must present themselves to Station staff by the third time their name is announced for verification as a potential Qualifier in this Contest. Subject to verification of eligibility and compliance with these Contest rules, they will be designated as a "**Qualifier**" in this Contest, receive one (1) qualifying prize (*as described in Section 12 below*), and be invited to participate in the Grand Prize Event (*as described in Section 6 below*). In the event that a selected On-Site Entrant is not eligible for any reason, or does not come forward before or immediately following the third time their name is announced, that selected On-Site Entrant will be disqualified and the Station will continue the random drawing in a similar manner until a verified Qualifier is found or until no entries remain, whichever comes first.
- i. **TO QUALIFY, YOU MUST BE PRESENT FOR THE DRAWING(S) AND, IN THE EVENT YOUR ENTRY IS SELECTED, PRESENT YOURSELF TO THE STATION STAFF AS REQUIRED ABOVE. ALL DECISIONS BY STATION STAFF AND/OR MANAGEMENT ARE FINAL.**
 - ii. All entry forms must be complete and received by 10:59am (ET).
 - iii. Limit of one (1) entry per person.
 - iv. If the Station does not receive at least one (1) entry during the On-Site Entry Period in this Contest, there will be no Qualifier by means of the On-Site method of entry.
 - v. There will be up to, but no more than, one (1) Qualifier from the On-Site method of entry in this Contest.

3. A PERSON MAY BECOME A QUALIFIER ONCE IN THIS CONTEST, AND OBTAIN ONLY ONE (1) QUALIFIER SPOT IN THE GRAND PRIZE EVENT. ONCE A PERSON OBTAINS A QUALIFIER SPOT IN THIS CONTEST, THEY WILL BE DISQUALIFIED IF SELECTED AGAIN AS A POTENTIAL QUALIFIER.
4. ONLY THE ACTUAL CONTESTANT WHO ENTERED THIS CONTEST CAN BE A QUALIFIER. CONTESTANTS CANNOT TRANSFER OR ASSIGN THEIR QUALIFYING SPOTS TO OTHER PERSONS.
5. There will be up to a maximum of eleven (11) Qualifiers in this Contest, consisting of up to ten (10) Qualifiers from the Online Video Entry method of entry (*as described in Section 2(a) of these rules*), and up to one (1) Qualifier from the On-Site method of entry (*as described in Section 2(b) of these rules*).

How to Win

6. To be eligible for the Grand Prize (*as described in Section 6 below*) Qualifiers must check-in with Station staff at Planet Fitness, located at 288 John R Rd, Troy, MI 48083 between 10:30am (ET) and 11:00am (ET) on Saturday, April 18, 2026 and remain present until the end of the event at approximately (12:00 pm) (ET) (the "**Grand Prize Event**"). Upon check-in, each Qualifier will receive one (1) Planet Fitness t-shirt in their size to wear for participation in the Grand Prize Event. A large variety of sizes will be available; however, in the event that a correct size or a size that fits well enough that it does not hinder a Qualifier's ability to participate, is unavailable, or if for any physical reason the Qualifier is unable to wear the Planet Fitness t-shirt, then that certain Qualifier will be allowed to participate without wearing the t-shirt. Whether or not a Qualifier is able to wear their Planet Fitness t-shirt for the Grand Prize Event will not affect their ability to participate in the Grand Prize Event and will not affect their chances of winning.
 - a. Qualifiers must present a valid government-issued photo ID and will be required to sign a liability release agreement and eligibility acknowledgement form "as-is" at check-in. Any Qualifier who does not sign the required liability release will not be allowed to participate in the Grand Prize Event.
 - b. Any one Qualifier who has not checked-in by 11:00am (ET), or who is not waiting in line to do so by 11:00am (ET), will be disqualified and that Qualifier's opportunity to participate in any portion of the Grand Prize Event shall be forfeited and no alternate Qualifier will be selected to take their place.
 - c. No stand-ins or proxies for Qualifiers will be allowed.
7. At approximately 11:01am (ET), or once any Qualifier who is waiting in line to check-in at 11:00am (ET) has done so, all checked-in and verified Qualifiers, will one by one randomly select a number between one (1) and the total number of verified and checked-in Qualifiers (up to eleven (11)) from a designated envelope. This number will determine the order that each Qualifier will dance in each round at the Grand Prize Event starting with lowest to highest (the "**Grand Prize Event Order**").
8. At approximately 11:05am (ET) on Saturday, April 18, 2026, or once all checked-in and verified Qualifiers have selected a number and the Grand Prize Event Order is determined, the Grand Prize Event will begin. The Grand Prize Event will be separated into three (3) rounds in which each Qualifier will dance one by one in-front of a panel of designated Station and/or Planet Fitness judges (the, "**Event Judges**") for a minimum of sixty (60) seconds to music provided by the Station and/or Planet Fitness. At the end of each round,

the Event Judges will select, based on an evaluation of the Qualifier's dance (in their subjective opinion) and/or any other lawful criteria Event Judges deem desirable, a certain number of Qualifiers to continue to the next round by the process described below. Any Qualifier not selected by the Event Judges to continue to the next round will be eliminated from the Grand Prize Event and will no longer be eligible to win the Grand Prize (as described in Section 13 below). Once the Grand Prize Event Order has been determined, each Qualifier will then be allowed to choose a sixty (60) second track of music from a selection of tracks provided by Station and/or Planet Fitness which will be the music played for their dance performance. **Qualifiers may not provide their own music for their dance performance at the Grand Prize Event.** Once Qualifiers have selected their sixty (60) second dance track from the music provided by Station and/or Planet Fitness, Round 1 of the Grand Prize Event will begin.

- a. **All Qualifiers must remain at the Grand Prize Event for the entirety of the event, including all three (3) rounds of judging. If any Qualifier departs the Grand Prize Event AT ANY TIME prior to the start or completion of the Grand Prize Event, REGARDLESS OF THE REASON, that Qualifier will be automatically disqualified from further participation in the Grand Prize Event.**
- b. All Qualifiers must be solo dancers.
- c. Qualifiers may not use large, elaborate, or dangerous props during their dance performance. Only props of a simple decorative nature (e.g. a hat, sunglasses, a shawl) or simple functional props required for the performance (e.g. a small portable tap dance floor) will be allowed. The Station and/or Planet Fitness reserve the right to determine the allowance of any certain prop at their own discretion.
- d. All Qualifiers must dance for judges for the full sixty (60) seconds of music. If it is determined by the Station in its sole discretion that a Qualifier did not complete a full sixty (60) seconds of dancing, that certain Qualifier will be disqualified from the Contest.
- e. All Qualifiers must have appropriate and safe shoes on while dancing, as determined in the sole discretion of the Station.
- f. Qualifiers may not violate any federal, state or local laws and must not harm or endanger themselves or other persons or property. Any Qualifier who the Stations determine may have created a public hazard, caused interference with or destruction of property and/or utilized public safety resources will be disqualified.
- g. Qualifiers must remain fully clothed; nudity will not be allowed. During the Grand Prize Event, foul play will not be tolerated. No indecent exposure or language will be permitted.
- h. The Stations reserve the right to call an official "time out", temporarily suspending and then resuming any event at any time, for any reason, in Stations' sole discretion.
- i. Stations and their representatives reserve the right to taunt, jeer, or mock the Qualifiers.
- j. Stations reserve the right (but does not have the obligation) to disqualify any Qualifier for any reason, including, without limitation, excessive harassment of other entrants, use of profanity, unhygienic habits or activities, or inappropriate touching of other Qualifiers or other people present at the Grand Prize Event.
- k. Qualifiers may not make any physical contact with other Qualifiers or any other people at any time during the Grand Prize Event.
- l. In no event will any "deal-making" between Qualifiers be permitted. Stations reserve the right to disqualify any person that it suspects has participated in or offered or accepted any type of "deal-making" with respect to this Contest.
- m. By participating in the Grand Prize Event, all Qualifiers acknowledge that such participation may be potentially hazardous, and hereby represent that they are physically, psychologically and medically able to participate in this activity. Qualifiers assume all risks associated with participation in this Contest. Qualifiers also expressly

consent to any physical contact that might naturally result from participation in this Contest and the Grand Prize Event.

9. **Round 1:** The up to eleven (11) Qualifiers will have the opportunity to dance to the music of Station's and/or Planet Fitness' choosing for sixty (60) seconds. Each Qualifier will dance solo for sixty (60) seconds in order based on the Grand Prize Event Order that was randomly assigned to each Qualifier at the time of checking in. Once sixty (60) seconds are up, the music will stop and the Qualifier must stop dancing. After all Qualifiers have danced for sixty (60) seconds, Round 1 will end and the judges will judge all Qualifiers based on any lawful criteria, and will eliminate six (6) Qualifiers. The six (6) eliminated Qualifiers must then exit the dance area and are no longer eligible to win the Grand Prize (*as described in Section 13 below*) in this Contest.
10. **Round 2:** The remaining five (5) Qualifiers will each become a "**Semi-Finalist**" and will have the opportunity to dance to the music of Station's and/or Planet Fitness' choosing for sixty (60) seconds. Each Semi-Finalist will dance solo for sixty (60) seconds in order based on the Grand Prize Event Order that was randomly assigned to each Qualifier at the time of checking in. Once sixty (60) seconds are up, the music will stop and the Semi-Finalist must stop dancing. After all Semi-Finalists have danced for sixty (60) seconds, Round 2 will end and the judges will judge all Semi-Finalists based on any lawful criteria, and will eliminate three (3) Semi-Finalists. The three (3) eliminated Semi-Finalists must exit the dance area and are no longer eligible to win the Grand Prize (*as described in Section 13 below*) in this Contest.
11. **Round 3:** The remaining two (2) Semi-Finalists will each become a "**Finalist**" and will have the opportunity to dance to the music of Station's and/or Planet Fitness' choosing for sixty (60) seconds. Each Finalist will dance solo for sixty (60) seconds in order based on the Grand Prize Event Order that was randomly assigned to each Qualifier at the time of checking in. Once sixty (60) seconds are up, the music will stop and the Finalist must stop dancing. After all Finalists have danced for sixty (60) seconds, Round 3 will end and the judges will choose one (1) "**Grand Prize Winner**" from the three (3) Semi-Finalists, based on any lawful criteria, who will receive the one (1) Grand Prize in this Contest (*as described in Section 13 below*).

Prize(s)

12. The up to eleven (11) Finalists in this Contest will, upon verification, receive one (1) one-year Planet Fitness Black Card membership, valid at any Planet Fitness location in Michigan and one (1) Planet Fitness t-shirt (each a "**Qualifying Prize**"). Each Qualifying Prize is valued at \$375.00 and is courtesy of Planet Fitness.
13. The one (1) Grand Prize Winner in this Contest will, upon verification, receive \$10,000 in the form of a company check made payable to the verified Grand Prize Winner only and made available approximately six (6) to eight (8) weeks from the date upon which the Grand Prize Winner completes and submits all documents required by the Station. (the "**Grand Prize**"). The Grand Prize is valued at \$10,000.00 and is courtesy of Planet Fitness.

Sponsor(s)

14. The administrator and sponsor of this Contest are Audacy Michigan, LLC d/b/ WOMC, WYCD, WWJ, WXYT, and WZLH and Planet Fitness.

Other Rules Specific to This Contest

15. The entry process may require Entrants to login to, or to create, a free account with the third party provider of a software platform used by the Station for such Contest(s) ("**Software**").

- a. Limit one (1) account with the Software Provider per email address.

In the event of any conflict between the Software Provider Policies and the Rules, the Rules will govern.

Station is not responsible for any error or technical malfunctions associated with the Software Provider site that may affect any Entrant’s ability to enter, to win, or to be properly considered in the Contest, regardless of the cause. In the event of a malfunction associated with the Software Provider site that the Station in its sole and absolute discretion deems to materially and adversely affect the Contest, the Station reserves the right to (1) suspend the Contest; (2) terminate the Contest without a Winner; (3) terminate the Contest and select a Winner early; (4) provide alternative means of entry; and/or make any other changes to the Contest that the Station deems appropriate under the circumstances. Any such changes, terminations or suspensions will be published on the Contest Rules Page, and in the Station’s sole and absolute discretion, may also be announced on-air, published elsewhere on the Website, and/or published on social media.
- f. Employees of Software Provider and its affiliates, their respective parents, affiliates, subsidiaries, advertising sponsors and promotional agencies, and the immediate family members of each are not eligible to win in this Contest.
