# Audacy Nevada and Desert Springs Pools 65K Pool Giveaway 2025 Contest Rules

Entrant or their legal spouse must be the record owner of a stand-alone or multi-family home (coops and condos are excluded) on the day of entry that is located within thirty (30) miles of the Stations in order to be eligible to win a prize in this Contest (an "Eligible Home"). If outside thirty (30) miles, an additional mileage charge will be required and the home may not be considered an Eligible Home.

The Stations will attempt to contact the one (1) Winner by telephone based on the number provided in the submitted entry. Odds of winning the Prize in this Contest shall depend upon the number of entries received in the Contest.

#### **Prizes**

5. The one (1) verified Winner will receive the following: one (1) pool by Desert Springs Pools and installation, valued at approximately \$65,000, inclusive of any assessments, materials, and installation services by Desert Springs Pools (the "**Prize**"). The exact Prize unit to be determined based on the size of the property and the installation location. Winner will receive the Prize that fits the Entrants' Eligible Home on the date of entry and installation and is located within a thirty (30)

mile radius of the Stations (as described in Section 2 above). Prize does include permits and applicable taxes. Prize value can be put towards adding additional construction. This is for a new pool only and cannot be used to upgrade existing pool and no cash Prize will be awarded. Failure to provide any of the foregoing may result in disqualification of the Entrant. The Prize is non-transferable. Winner must have 4ft access point to backyard. Home must be hooked up to county sewer system, no septic tank. Winner must provide gas and/or electric sufficient enough to run pool. Winner must have 15ft yard available from back of house to property line. There must be no power lines above pool installation area. Winner is responsible for maintenance and care of the pool once it is installed.

- a. Fulfillment of this Prize subject to final eligibility inspection and verification of the Winner's home by Desert Springs Pools to confirm such home meets the Eligible Home criteria set forth in Section 2 of these Contest rules above and is property will accommodate proper pool install. Permit must be pulled by December 31, 2025 and install date must be mutually agreed upon by Winner and Desert Springs Pools. Winner understands and agrees that Stations are not responsible for any delays or any damage resulting from the work at the home.
- This Prize (in its entirety) will be forfeited if: (i) the Winner or his/her legal spouse on the date of winning either is not the record owner of an Eligible Home or is not listed as a tenant on a residential lease of an Eligible Home; (ii) the Winner or his/her legal spouse is listed as a tenant on a residential lease but does NOT deliver to Stations the written consent of the record owner of the Eliqible Home within ten (10) days of receiving the required consent form from Stations (Stations will provide the required consent form); and/or (iii) if the Winner's home does not meet the Eligible Home definition and criteria as set forth in Section 2 of these rules.
