

WSTR - STAR 94 / Win Your Ultimate Dream Wedding at Lanier Islands

Official Contest Rules

These contest rules are specific to the above contest conducted by Audacy Georgia, LLC d/b/a WSTR ("Station"). Except to the extent specifically set forth below with respect to this specific contest, the Station's general contest rules apply to this contest as well. A copy of these specific contest rules and the Station's general contest rules are available on the Station's website at <https://www.audacy.com/star94atlanta/general-contest-rules>. **As a preventative measure in light of the COVID-19 (Coronavirus) pandemic, copies of the specific contest rules and the Station's general contest rules will not be available at the Station's studio. To the extent the general contest rules differ from these rules, these rules will govern and control with respect to this contest.**

HOW TO ENTER

1. No purchase is necessary to enter or win the WSTR STAR 94 / Lanier Islands Resort Wedding Contest (the "**Contest**"). A purchase or payment will not increase your chance of winning. **(DO NOT ENTER THIS CONTEST IF YOU AND YOUR SIGNIFICANT OTHER ARE NOT AVAILABLE TO ATTEND AN EVENT ON APRIL 26, 2025 AT LANIER ISLANDS RESORT, 7000 LANIER ISLANDS PARKWAY, BUFORD, GA 30518, (as further described in Section 10 below, the "Engagement Party Event").**
2. The contest entry period will begin at 7:00am (ET) on February 20, 2025 and end at 5:00pm (ET) on March 30, 2025 (the "**Contest Entry Period**")
3. Entrants must be 18 years of age or older and legally reside in Georgia as of the date of entry in this Contest (each an "**Entrant**"). In the event that a prize is won by an entrant who is under 18 years of age, for all purposes under these rules, the parent or legal guardian may be recognized as the actual winner of the prize for tax and liability purposes although only the entrant may utilize the prize.
4. Entrants in this contest can only be one (1) individual (each an "**Entrant**") and not a couple. **The Entrant's significant other shall not be considered an Entrant in this contest unless he or she submits a separate entry and is not entitled to any Prize in this contest in the event that his or her significant other is selected as the grand prize winner.**
 - a. A person and their significant other may each enter this contest separately.
 - b. Entrant and his/her significant other need not be of the opposite sex; provided, however, that only two-person couples shall be eligible to win the grand prize in this Contest.

To enter from 7:00am (ET) on February 20, 2025 through 5:00pm (ET) on March 30, 2025, visit star94atlanta.com/contests, click on the WSTR - STAR 94/ Win Your Ultimate Dream Wedding at Lanier Islands Contest link and complete the online entry/registration form by submitting the entrant's full name, phone number (including area code), age, e-mail address, and a sixty (60) second video describing why Entrant believes they deserve to win the Prize *(as described in Section 6 below)*.
 - a. Entrant represents and warrants that he/she is over eighteen (18) years of age or older.
 - b. Entrant represents and warrants that he/she authorizes Station to post the video submitted with entry on Station's website or social network sites or use the video in any other way Station sees fit, without the payment of any additional compensation to Entrant or Entrant's significant other.

6. Video Requirements:

- a. Video should be no more than sixty (60) seconds in length. Entries with a video comprised of more than sixty (60) seconds will not be disqualified, but only the first sixty (60) seconds will be reviewed and considered for the Contest.
 - b. Video need not be truthful. Station will not verify the truthfulness of the information submitted in each entry; provided, however, that failure to satisfy (or, suggestion that you fail to satisfy) the entry eligibility requirements or other Contest rules applicable to this Contest can result in disqualification of the Entrant from becoming the Grand Prize Winner, in Station's sole discretion.
 - c. Station reserves the right, but is under no obligation, to edit an Entrant's submission in any manner that it chooses at Station's sole discretion.

Station reserves the right to edit an Entry in its sole discretion. Not all entries will be posted to the Station's website and/or played on-air and in the event that Station posts or plays any such Entry it does not mean that such Entry has won or may be selected to win any prize in this Contest.
8. By entering this Contest, Entrants understand and agree that Station may elect to use any Entry submitted for entertainment purposes and may choose to comment on, mock, poke fun at, and/or mimic

any Entry submitted. Entrants waive any right to make any claim against Station with respect to any comments – disparaging or otherwise – made regarding such Entrant's Entry.

HOW TO WIN

9. On or about April 3, 2025, a panel of judges will select up to sixty (60) entries they like best from among all eligible entries received during the Contest Entry Period and based upon any lawful criteria that the judges deem desirable in their sole discretion, to continue in the Contest subject to verification of eligibility and compliance with these rules (each a “**Qualifier**,” collectively the **Qualifiers**”).
 - a. The Station will contact each potential Qualifier by means of the phone number and/or email provided by Entrant at time of Contest.
 - b. Notification to potential Qualifier may be made by message on the Entrant's voicemail, with no responsibility for any failure of the voicemail at the Entrant's phone number provided on the entry form.

 - d. After 12:00pm (ET) on April 28, 2025, the panel of Judges will select the one (1) Finalist video they like best, based upon evaluation of the Finalist videos in their subjective opinion and/or based upon any other lawful criteria Judges deem desirable, to receive the grand prize (as *described in Section 18 below*), subject to verification of eligibility and compliance with these contest rules (the "**Grand Prize Winner**"). **Judges may, but are not obligated to, take the number of votes received into consideration, but voting will not be a determining factor in the selection of the winner.**
 - a. Station will announce the name of the potential Grand Prize Winner on air at approximately 8:00am (ET) on April 30, 2025. Potential Grand Prize Winner need not be listening in order to win.

 - iii. Reception food includes one display platter, two (2) passed Hors d'Oeuvres platters...Buffet: Two (2) salads / Two (2) entrees / Two (2) sides / One (1) carving station, One (1) Carver, One (1) Bartender, Service Staff and Event

Captain. All beverages (nonalcoholic and alcoholic) must be provided by the venue.

iv. Includes all place settings and glassware, and appropriate service/wait staff. Sales tax and gratuity is included.

v. Cake cutting service (Cake is not included) and champagne toast. Champagne is included for champagne toast (1 glass per person)

vi. Hotel centerpieces for each table (non-floral)

c. GIFT CERTIFICATE MAY NOT BE REDEEMED FOR, AND NO ITEM ABOVE SHALL BE DEEMED TO INCLUDE OFFICIANT, DJ / ENTERTAINMENT, STAGING FOR ENTERTAINMENT, FLOWERS, ROOM DÉCOR, CAKE, TUXEDO RENTAL, DRESSES, HAIR/MAKEUP, PERSONAL WEDDING PLANNER, HOTEL ACCOMMODATIONS, TRANSPORTATION, AUDIO VISUAL EQUIPMENT OR OTHER AMENITIES OF THE RESORT.

d. Grand Prize winner assumes full responsibility: (i) for the conduct of all persons occupying the building or attending the wedding, including providing supervision for children, (ii) for ensuring all items brought onto the Venue property be removed at the end of the evening (including décor, favors, gifts, signs, etc...), (iii) for any damage to the facility or premises caused by guests, vendors or independent contractors in connection with the event.

19. The venue is not responsible for damage or loss of articles or merchandise left on the premises prior to, during or following your event.

Sponsor(s)
