

## Metallica Sphere Residency Download & Listen Official Rules

These rules are specific to the above contest conducted by Audacy Operations, LLC (the “**Contest Administrator**”). A copy of these rules is available at [www.audacy.com/contest-rules](http://www.audacy.com/contest-rules).

### Who Can Enter

---

- NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR TO WIN THE METALLICA SPHERE RESIDENCY DOWNLOAD & LISTEN CONTEST (the “CONTEST”). A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.**
- THIS CONTEST IS SUBJECT TO AND GOVERNED BY APPLICABLE FEDERAL, STATE AND LOCAL LAWS, STATUTES, AND REGULATIONS. PARTICIPATION IN THIS CONTEST IS VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.**

  - h. ## How to Win

7. On or about March 11, 2026, the Contest Administrator will randomly select one (1) entry from among all eligible entries received as the winner of this Contest subject to verification of eligibility and compliance with these Contest rules (the "**Winner**").
8. The potential Winner will be notified within twenty-four (24) hours of being selected via email at the email address associated with potential winning entrant's Audacy App account. Contest Administrator is only required to send one (1) email. Notification is deemed to have occurred immediately at the time the Contest Administrator communicates such notification. Contest Administrator reserves the right, but not the obligation, to attempt to contact the Winner more than once via email and/or via telephone, in its sole and absolute discretion, and will not be required to attempt to contact Winner an equal number of times or in the same manner. If the potential Winner cannot be contacted, or if Contest Administrator does not receive a response from the potential Winner within forty-eight (48) hours of notification from Contest Administrator, then the prize will be forfeited. If the potential Winner does not complete and submit all documents required by the Contest Administrator within five (5) days of being notified of winning, then the prize will be forfeited. In



the event that the prize is forfeited, the Contest Administrator has the right, but not the obligation, in its sole discretion, to select an alternate Winner in a random drawing of all remaining eligible online entries received.

## **Prize(s)**

---

9. The one (1) verified Winner(s) of this Contest will receive one (1) trip for two (2) (the Winner and one (1) guest age 21 or older to see Metallica in Las Vegas, NV, consisting of the following: (i) roundtrip coach airfare between a major commercial airport near the Winner’s home (as determined in the sole discretion of the Contest Administrator) and a major commercial airport in Las Vegas, NV, (as determined in the sole discretion of the Contest Administrator) departing on October 1, 2026 and returning on October 4, 2026; (ii) three (3) nights hotel accommodations (one (1) room, standard double occupancy) at a hotel in the Las Vegas, NV area (as determined in the sole discretion of the Contest Administrator) checking in on October 1, 2026 and checking out on October 4, 2026; and (iii) two (2) tickets to see Metallica at Sphere, 255 Sands Ave, Las Vegas, NV 89169 on October 1, 2026 and October 3, 2026 (the “**Prize**”). The total value of the Prize is estimated at (but will not exceed) \$4500.00 and is provided by Q Prime. (“Live Nation”). The actual value of the Prize awarded will depend upon the Winner’s origin city (in no event will the Winner be entitled to any difference (in cash or other prizes) in value between \$4500.00 and the actual Prize value). Ground transportation and incidentals are NOT included in the Prize.
10. **Contest Administrator reserves the right, as determined in its sole discretion, to: (i) substitute ground transportation for airfare if the Winner resides within 100 miles of Las Vegas, NV and any difference in value will not be awarded; and (ii) assign an earlier departure and hotel check-in date of up to twenty-four (24) hours if Winner’s residence prevents arrival in time for the October 1, 2026 show. In the event the Winner resides in a location where distance may create The Winner and their guest must travel on the same itinerary. Once the reservations are made, no changes may be made by a Winner (including, without limitation, any changes in traveling companions).**
