

WEEI-FM FANATICS FANCASH CONTEST RULES

These contest rules are specific to the above contest conducted by Audacy Massachusetts, LLC d/b/a WEEI-FM, WVEI(AM), and WVEI-FM (each individually or collectively, as applicable, “**Station**”). Except to the extent specifically set forth herein with respect to this certain contest, the Station’s [general contest rules](#), incorporated herein by this reference, apply to this contest as well. In the event of conflict between the Station’s general contest rules and these specific contest rules, these specific contest rules will govern and control with respect to this Contest. A copy of these specific contest rules and the Station’s general contest rules are available at the Station’s studio at 83 Leo M. Birmingham Parkway, Brighton, MA 02135 during regular business hours, and on the Station’s website at www.weei.com/rules.

CERTAIN PROGRAMS BROADCAST ON WEEI-FM ARE, FROM TIME-TO-TIME, BROADCAST ON CERTAIN OTHER RADIO STATIONS THROUGHOUT NEW ENGLAND. AS A RESULT, SOME WEEI-FM STATION CONTESTS (BOTH ON AND OFF AIR) MAY BE OPEN FOR LISTENERS, WEBSITE VISITORS, FRIENDS, AND FANS OF SUCH OTHER RADIO STATIONS TO ENTER AND WIN, SUBJECT TO ALL RULES FOR ANY SUCH CONTESTS. WHEN AND TO THE EXTENT APPLICABLE FOR SUCH CONTESTS, THE DEFINITION OF “STATION” IN THESE CONTEST RULES WILL BE DEEMED TO APPLY COLLECTIVELY TO THE STATION, AND ANY AND ALL SUCH OTHER RADIO STATIONS.

Who Can Enter

1. No purchase or payment of any kind is necessary or required by Station to enter the “WEEI Fanatics FanCash” contest (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. To enter this Contest, and potentially become a winner and receive a prize, you must (i) be twenty-one (21) or older and a legal resident of Massachusetts, Connecticut, or Vermont as of the entry date; and (iii) have or be eligible to create a Fanatics Sportsbook account.
 - a. You can create a Fanatics Sportsbook account on the Fanatics Sportsbook App.
 - b. Creating a free Fanatics Sportsbook account requires (i) verification of your identity by Fanatics Sportsbook; and (ii) your acknowledgement of, and agreement to, Fanatics Sportsbook’s Terms of Service and House Rules.

Each Friday from May 22, 2026 through and including December 18, 2026 (**excluding, Friday, June 19, 2026, Friday, July 3, 2026, and Friday, November 27, 2026**) (each, a “**Contest Day**”), listen to the Station between 6:00am and 10:00am ET for the announcement to be the 10th caller at 617-931-0937 (each, a “**Contest Play**”).
 - a. **WARNING! ONLINE LISTENERS TO STREAMED BROADCASTS MAY EXPERIENCE A LAG IN TRANSMISSIONS DUE TO BUFFERING LIMITATIONS. CONTEST PARTICIPANTS SHOULD NOT RELY ON STREAMED BROADCASTS.**
 - b. Only calls received to the studio contest phone number above are eligible to win (calls to the main radio station phone number or any other phone numbers are not acceptable).
 - c. There will be up to, but in no event more than, twenty-eight (28) Contest Plays in this Contest.



5. Subject to verification of eligibility and compliance with all terms and conditions set forth in these Contest rules, the 10th caller in a Contest Play will receive a Prize (*as defined in Section 9 below*) (each, a “**Winner**”). If the 10th caller does not meet the eligibility requirements for entry in this Contest, he/she will be disqualified and the Station will take the 11th caller, and so on until either (i) a Winner has been verified for such Contest Play or (ii) thirty (30) minutes has elapsed since the first on-air announcement for such Contest Play, in which case, there will be no winner and no prize awarded for such applicable Contest Play. Notwithstanding the foregoing, Station staff may elect, in their sole and absolute discretion and on a case-by-case basis, but shall in no way be obligated, to continue any Contest Play beyond the foregoing time deadline if there is still no Winner; provided, however, Station staff shall not be obligated to make the same decision regarding any Contest Play for any other Contest Play.

- a. There will be up to, but in no event more than, twenty-eight (28) Winners in this Contest.
- b. Station may, but shall in no way be obligated to, feature Winner in an on-air segment with the on-air talent. The length of such a segment, if any, may vary and be different for each Winner. - a. FanCash issued in connection with this Contest expires at 11:59 pm ET three hundred sixty-five (365) days from the date of issuance. Promotional FanCash expiring first will automatically be applied first.
