

## 30 SECOND SONG CHALLENGE FLYAWAY CONTEST RULES

These contest rules are specific to the above contest conducted by Audacy New York, LLC d/b/a WCBS-FM (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. A copy of these specific contest rules and the Station’s general contest rules are available at the Station’s studio at 345 Hudson Street, 10<sup>th</sup> Floor, New York, NY 10014 during regular business hours and on the Station’s website at [www.wcbsfm.com/rules](http://www.wcbsfm.com/rules). To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this Contest.

### Entry/Winning

1. No purchase or payment of any kind is necessary to enter or win the 30 Second Song Challenge Flyaway (the “**Contest**”). A purchase or payment will not increase your chance of winning.
2. The CBS-FM 30 Second Song Challenge Flyaway Contest will consist of twenty (20) contest days: each weekday (*Monday – Friday*) starting Monday, January 5, 2026 and ending Friday, January 30, 2026 (each, a “**Contest Day**”). Each Contest Day will be a separate contest with up to one (1) grand prize winner, but the following rules will apply for all Contest Days. Listen each Contest Day at approximately 7:30am (ET), 8:30am (ET), and 4:30pm (ET) for the cue to call (each, a “**Contest Play**”). Upon hearing the cue to call, the correct number caller (as *announced by the on-air personality prior to the cue to call*) at 1-800-367-1101, will, upon verification of eligibility, be entered in to the drawing to win that Contest Day’s Grand Prize (as *described below in Section 7*) (each, a “**Grand Prize Qualifier**”) and will then have the opportunity to participate in the :30 Song Challenge (the, “**Song Challenge**”) for the chance to also win a Song Challenge Prize (as *described below in Section 6* ).
  - a. Only calls received to the studio contest phone number above are eligible to win (calls to the main radio station phone number or any other phone numbers are not acceptable).

3. To win the Song Challenge Prize (as *described below in Section 6*), each Grand Prize Qualifier will need to correctly identify all seven (7) songs in the Song Challenge by naming the song title of each song clip played in thirty (30) seconds or less. The first song clip will play until the correct song title is given before moving to the next song. If the Grand Prize Qualifier correctly names all seven (7) song titles played, that Grand Prize Qualifier will win the Song Challenge Prize (as *described below in Section 6*), upon verification of eligibility and compliance with these Contest rules (each a “**Song Challenge Prize Winner**”). If a Grand Prize Qualifier does not correctly identify all seven (7) songs in thirty (30) seconds or less that Grand Prize Qualifier will not be a Song Challenge Prize Winner and will not receive the Song Challenge Prize but will still remain a Grand Prize Qualifier for that Contest Day’s Grand Prize.
4. There will be up to one (1) Grand Prize awarded each Contest Day, and each Contest Day will have up to three (3) Contest Plays with a total of up to three (3) Grand Prize Qualifiers, and up to three (3) potential Song Challenge Prize Winners. There will be an overall total of up to sixty (60) Grand Prize Qualifiers and potential Song Challenge Prize Winners, and up to twenty (20) Grand Prize Winners.
5. On or around 5:00pm (ET) of each Contest Day, one (1) Grand Prize Winner will be randomly selected from among that Contest Day’s up to three (3) Grand Prize Qualifiers, and upon verification of eligibility and compliance with these Contest rules, will win the Grand Prize (as *described in Section 7 below*) (a “**Grand Prize Winner**”).
6. No one (1) person may be a Song Challenge Winner and/or a Grand Prize Winner more than once in this Contest.
7. The odds of becoming a Grand Prize Qualifier depend on the number of calls received. The odds of becoming a Song Challenge Prize Winner depend on the skill and knowledge of the Grand Prize Qualifier. The odds of a Grand Prize Qualifier winning a Grand Prize are up to but no more than 1:3.



## Prize(s)

8. There will be up to sixty (60) potential Song Challenge Winners in this Contest. Each Song Challenge Winner will receive one (1) \$100 Visa digital e-Gift Card (redeemable at any merchant that accepts Visa digital e-Gift Cards, cannot be redeemed for cash or replaced if lost, stolen, or damaged, full terms and conditions can be found [HERE](#)), courtesy of Audacy New York, LLC (each a "**Song Challenge Prize**").
9. There will be up to twenty (20) Grand Prize Winners in this Contest (*one (1) for each Contest Day*). - viii. Prizes are non-transferable, cannot be sold or gifted, may not be redeemed for cash, and will not be replaced if lost or stolen. Extensions to expiration dates will not be granted. Prize packages do not include travel to the departure airport or to the hotel (except as specifically included), meals (except as specifically included), incidentals, tips, telephone calls, airline baggage fees, or any other personal expenses incurred during the winner's stay.
